

Certificates to the Head of the School:
(i) Medical certificate of fitness from Chief Medical Officer.
(ii) Attested copies of academic and professional qualification and matriculation certificates and
(iii) A certificate of good and moral character from a Gazette Officer/M.L.A./M.C.

CONTRACT OF SERVICE

An agreement made this fifteen day of 15 March two, thousand,
and Twenty one Between Mr /Mrs .. Miss Mandeep Kaur

hereinafter called the teacher/employee of school the party No.1 of the one part and the governing body of the school (Manavta Public Sr. Sec. School, Ferozepur). the party No. 2 of the other part the committee hereby agrees to employ the party No. 1 and Party No. 1. hereby agrees to serve as in the school on the following terms and conditions:

1. That party No.1 IS employment shall begin from the ... 15 March day of 2015. He shall be employed in the first instance on probation for a period of 1 one year/on temporary basis and shall be paid a monthly salary of Rs 15300 in the scale of pay of Rs 15300 Plus allowances in accordance with the rates as prescribed by the central Govt. from time to time and applicable to his case. The period of probation may be standard by Governing body for a future period not exceeding one year. the total probationary period shall in no case exceed two years.
2. In work and conduct of the Party No.1, during the period of probation or extended period of probation is not found satisfactory, the services of party No.1 are liable to be terminated without notice before the expiry of the period of probation. The sole judge of the satisfactory completion of the probation will be Governing Body of the School.
3. After satisfactory completion of his probationary period, the Party No.1 shall be confirmed with effect from the expiry of the said period of probation or the extended period of probation.
4. Immediately on confirmation the Party No.1 shall be entitled to the benefits of contributory provident fund or GP fund in case the scheme of person exits in school and shall be Governed by the rules of the fund as in force time to time.
5. The Party No.1 shall be entitled to the benefit of medical and other facilities as per school rules.
6. The Party No.1 shall during his service under the agreement with eligible subject to the exigencies of the school to such leave as is admissible under the Government rules from time to time in force, the leave not claimable as a matter of right but may be granted at the discretion of the Governing body of the school/Principal of the school as per rules of the school in this regard.
7. The Party No.1 shall not leave the station without having first obtained written permission of the authorised officer of the said school.
8. Unless the service of the Party No. 1 is terminated as hereinafter provided, he shall continue in the employment of the school till he attains the age of superannuation as per state Govt. rules, when he shall retire, provided that the committee or any other person authorized by the committee in this behalf may retain his service for a future period as admissible according to rules of the state education Deptt. for such extension if the Party No. 1 is fit for such extension and has no mental and physical incapacity which would disentitle him to get such extension. Provided that future that the extension shall not exceed one year at a time
